# ACCUSED OF KILLING

## Man New York Police Could Not Find Calmly Yields.

BROTHER ARRANGED 'TREATY'

In Ten-Day Negotiations Man Who Is Alleged to Have Shot John Rizzo and Two Policemen Fixes Time of Surren der and Names Officers Who Are to Take Him-Turns Up Smiling.

wanted for the murder of Policemen Teare and Heaney and John Rizzo, Italian gangster, was given up to the police by his brother John today, after ten days negotiations between the police and the young Italian's relatives. He was im-mediately taken to police headquarters, where he was duestioned by Commissioner Waldo.

The conference lasted for half an hour. At the end of it Lieut. Dominick Reilly gave out the strange story of the arrest, which followed a vain search of weeks by the police force of the city, aided by officials of many other cities.

#### Brother Makes Deal.

Ten days ago Lieut. Reilly met John Shillitoni, and the brother of the alleged slayer declared he would like to arrange a deal with the policeman for the surrender of Oresto. He specified that his brother should not be harmed by the police, and that the arrest should be made only by Detectives Lebario Gamberdillo and Frank Bonano.

Negotiations between the detectives and Shillitoni went on for several days. An agreement finally was made that satis-fied the fugitive's brother.

Today at 9 a. m. was set as the time for the surrender. The place was 1236 and Morningside avenue. True The place was 123d street to his promise, John Shillitoni appeared with Oresto, who willingly followed the two detectives to police headquarters.

#### Hold Family Reunion.

In the hall at headquarters the party was met by Oresto's mother, his aunt, and two other brothers, Sam and Fred. The prisoner was smilling pleasantly, and seemed far from alarmed at his predica-ment. He greeted the members of his family effusively. They seemed over-joyed to see him. There were no tears at the reunion, and not the slightest hint that they realized the youth was soon to

that they realized the youth was soon to be charged with a triple murder. He was taken to Deputy Commissioner Dougherty's office, where Inspector Fau-rot was also present. Commissioner rot was Waldo so soon entered, and remained half an hour.

ment until he be Shillitoni refused to make any state-ment until he had had the advice of counsel. Neither he nor his brother would tell anything about where he had been hiding while the police of every city in the country were looking for him.

#### Accused of Three Killings.

Oresto Shillitoni, alias "Harry Shields," alias "The Paper Box Kid," was wanted for the murder of Patrolmen Charles J. Teare and William G. Heaney, of the Teare and William G. Heaney, of the Mulberry Street station, and John Rizzo, an Italian. A short, slender Italian. pock-marked and swarthy, Shillitoni sat in the office of Deputy Police Commissioner George S. Dougherty, at police headquarters and snickered in the faces of Police Commissioner Waldo and Inspector Joseph Fau-rot, criminal identification expert of the the police department. The fact that he had been sought for more than a month on a triple murder charge, apparently preyed but little on his mind. Shillitoni was questioned regarding the

murders. He gave but one answer.

### District Attorney Questions.

After being half an hou Commissioner Dougherty's hour in Deputy office Shillitoni was taken to the offices of Assistant District, Attorneys Charles C. Nott, jr., and Deacon Murphy, where the interro-gation was resumed. gation was resumed.

Teare; Teaney, and Rizzo were shot in front of a coffee house at 235 Mulberry street on May 3. Heaney and Rizzo died at once. Teare died later in a hospital.
